University of Exeter Students' Guild Society Constitution

1 Name

- The name of the group shall be Commercial Awareness Society, hereafter referred to as 'the group'. 1.
- The date this document was last updated was 21/03/2024. 2.
- 3. This Constitution may be amended by a two-thirds majority of those present and eligible to vote at an Annual General Meeting of the society
- 4. Any amendment is subject to ratification by Societies Council.
- 5. This Constitution does not supersede any Guild Byelaws.

Aims and Objectives 2.

The Aims and Objectives define the purpose of the group.

- Encourage active engagement with current affairs and business 1.
- 2. Improve students' employability by developing commercial awareness as a core skill
- 3. Build the confidence of members in expressing their opinions

2. Membership

- Membership of the group shall be open to all members of The Guild in accordance with The Guild's 1. Byelaws.
- All members are required to register or pay a membership fee for the year. The group committee will 2. set the membership fee(s) annually.
- 3. Anyone who is not a full member of the Students' Guild must purchase an associate membership before joining the group.

Committee 3.

- The group should have a committee consisting of officers in the following mandatory positions. 1. These committee members shall be elected by the group's membership as per section 7. 1.
 - 4.1.1.Co-presidents
 - 4.1.2.Vice President
 - 4.1.3.Treasurer

- 4.2.1. Head of Marketing
- 4.2.2. Socials and Events Manager
- All committee members shall attend committee training. 3.
- All committee members shall complete the Student Committee Agreement. 4.
- Any new roles to the committee shall only be added with the consent of the Membership at an 5. Annual General Meeting or Extraordinary General Meeting. Minutes will be required by Activities for verification.
- The role of the committee is to manage all aspects of the group's administration and activity. The 6 committee shall not work autonomously. Planning activities, buying equipment and administering other group matters should be done in accordance with the wishes of group members and guidance of the Activities team
- The committee has a joint responsibility to ensure that all information is effectively communicated 7 both within the group to its members, and to Guild staff.
- The committee will ensure that the society, their roles and the activities of the society are open and 8 inclusive to all Members and will proactively seek to enhance opportunities for all.

Committee Roles 4

- Co-Presidents: 1
 - 5.1.1.The President shall be the principal officer and spokesperson for the society 1. and the chairperson of committee meetings and the AGM
 - 2. 5.1.2. They shall have overall responsibility for the promotion and development of the society.
 - 3. 5.1.3. They shall ensure that the group does not contravene The Guild's Byelaws or any guidelines or policy of the Activities team.
 - 4. 5.1.4. They shall have the responsibility to write and sign off financial forms of the society.
 - 5. 5.1.5. The President has the overall responsibility to respond to communication from the Activities Team
- 2 Treasurer
 - 5.2.1.The treasurer shall be the chief financial officer and accountant for the 1. society.
 - 2. 5.2.2. They shall ensure that all members have purchased membership

- 3. 5.2.3.They shall have the responsibility to write and sign off financial forms of the society.
- 4. 5.2.4. They shall work with the Socials and Events Manager to ensure that socials align with the society's budget.
- 3. Vice-President
 - 1. 5.3.1.The Vice-President will support and deputise for the President, providing leadership and direction to the other Committee roles where required.
 - 2. 5.3.2.They shall support the other Committee roles to deliver their remit and work to ensure all Members are engaging with the Society.
- 4. Head of Marketing
 - 1. 5.6.1.The Head of Marketing shall be responsible for all the society's social media handling
 - 2. 5.6.2.They shall be responsible for designing, creating and promoting content that will be shared across the society's social media platforms
 - 3. 5.6.3.They shall be the first point of contact for the society
 - 4. 5.6.4.Must be innovative in utilising new ways to increase public engagement with the society

1. Finance

- 1. The group's finances shall be administered by The Guild, on behalf of the group's members. Such funds will be held in trust by The Guild on behalf of the group and shall not be used for purposes other than the group's aims and objective.
- 2. All funds shall be used as to benefit the largest number of members possible at all times.
- 3. Where the group is dormant, The Guild will hold funds in trust until a time when the group becomes active again or is disaffiliated from the Students' Guild.
- 4. The group shall follow all Guild financial guidelines, and shall ensure that all monies are handled through the respective Guild accounts.
- 5. The committee can endeavour to secure external sponsorship for the group. Any sponsorship agreement must be approved by the Activities team prior to the signing of an agreement or money being received.
- 6. Any equipment or other items purchased by the group using group funds shall remain property of The Guild.

2. Safety

- 1. The group will follow all guidelines and policies laid down by the Activities Team and The Guild.
- 2. The committee must complete their due diligence by risk-assessing all events and activities organised by them in line with Guild procedures.
- 3. All events undertaken by the group must be submitted to and approved by the Activities Team within the stated deadlines.

3. Elections

- 1. All the Executive Committee shall be elected. Voting shall be by single transferable vote and secret ballot, using the online election system provided by the Guild.
- 2. All full members of the society may stand for election
- 3. Associate members may not stand or vote for executive committee positions.
- 4. No committee members will serve for longer than one year without re-election.
- 5. Members should be given at least two weeks' notice of any election.
- 6. The group may hold by-elections at any point during the year if a position becomes vacant. The
- by-election may either be held at an Extraordinary General Meeting or online via The Guild website.7. By-elections shall follow the same regulations as regular elections.

4. Meetings

- 1. Committee Meetings
 - 1. 9.1.1.Committees shall hold regular minuted meetings.
 - 2. 9.1.2.Any member of the group is entitled to attend any committee meeting,
 - unless it is a closed meeting
- 2. Annual General Meeting
 - 1. 9.2.1.The group will hold an AGM before the end of Term 3, during which the following will take place:
 - 1. 9.2.1.1.each committee member will deliver an outgoing report of the year.
 - 2. 9.2.1.2.the treasurer will present a report of the financial accounts
 - 3. 9.2.1.3.any constitutional amendments will be voted on
 - 2. 9.2.2.All members must be given at least two weeks' notice of this meeting
