

University of Exeter Students' Guild Society Constitution

1. Name

- 1.1. The name of the group shall be *Liberal Democrat Society*, hereafter referred to as 'the group'.
- 1.2. The date this document was last updated was *01/09/2020*
- 1.3. This Constitution may be amended by a two-thirds majority of those present and eligible to vote at an Annual General Meeting of the society
- 1.4. Any amendment is subject to ratification by Societies Council.
- 1.5. This Constitution does not supersede any Guild Byelaws.

2. Aims and Objectives

The Aims and Objectives define the purpose of the group.

- 2.1. To foster an engaging and social environment for Liberal Democrats at Exeter University.*
- 2.2. To learn together and share knowledge about the political philosophy of Liberalism.*
- 2.3. To campaign for the Liberal Democrat party in local and national elections.*

3. Membership

- 3.1. Membership of the group shall be open to all members of The Guild in accordance with The Guild's Byelaws.
- 3.2. All members are required to register or pay a membership fee for the year. The group committee will set the membership fee(s) annually.
- 3.3. Anyone who is not a full-member of the Students' Guild must purchase an associate membership before joining the group.

4. Committee

- 4.1. The group should have a committee consisting of officers in the following mandatory positions. These committee members shall be elected by the group's membership as per section 7.
 - 4.1.1. President
 - 4.1.2. Treasurer
 - 4.1.3. *Publicity and Speakers Secretary (third financial approver)*
- 4.2. Additional roles are:
 - 4.2.1. *Social Secretary*
 - 4.2.2. *Freshers Representative*
- 4.3. All committee members shall attend committee training.
- 4.4. All committee members shall complete the Student Committee Agreement.

- 4.5. Any new roles to the committee shall only be added with the consent of the Membership at an Annual General Meeting or Extraordinary General Meeting. Minutes will be required by Activities for verification.
- 4.6. The role of the committee is to manage all aspects of the group's administration and activity. The committee shall not work autonomously. Planning activities, buying equipment and administering other group matters should be done in accordance with the wishes of group members and guidance of the Activities team.
- 4.7. The committee has a joint responsibility to ensure that all information is effectively communicated both within the group to its members, and to Guild staff.
- 4.8. The committee will ensure that the society, their roles and the activities of the society are open and inclusive to all Members and will proactively seek to enhance opportunities for all.

5. Committee Roles

5.1. President:

- 5.1.1. The president shall be the principal officer and spokesperson for the society and the chairperson of committee meetings, the AGM and EGMs.
- 5.1.2. The President shall attend meetings with their elected representative officer, as the representative of the society.
- 5.1.3. They shall have overall responsibility for the promotion and development of the society.
- 5.1.4. Ensure that the group does not contravene The Guild's Byelaws or any guidelines or policy of the Activities team.
- 5.1.5. They shall have the responsibility to write and sign off financial forms of the society.
- 5.1.6. The President has the overall responsibility to respond to communication from the Activities Team
- 5.1.7. *The President will deliver a monthly email to all society members, discussing the progress of the society, plans for the next month, as well as any other relevant news.*
- 5.1.8. *The President is responsible for responding to messages sent to our the group's Facebook page.*

5.2. Treasurer

- 5.2.1. The treasurer shall be the chief financial officer and accountant for the society.

- 5.2.2. The treasurer shall attend meetings with their heir elected representative officer, as the representative of the society.
- 5.2.3. The treasurer shall set and oversee the production of an annual budget and present a financial report to all members at the AGM.
- 5.2.4. They shall ensure that all members have purchased membership
- 5.2.5. They shall have the responsibility to write and sign off financial forms of the society.
- 5.2.6. *The Treasurer will procure Stash for all of the society.*

5.3. Publicity and Speakers Secretary

- 5.3.1. *Controls our Facebook, Twitter and Instagram outputs.*
- 5.3.2. *Responsible for communicating with invited and potential speakers.*
- 5.3.3. *Must liaise with speakers and the social secretary to organise our speakers events.*
- 5.3.4. *Makes graphics and videos to be used for advertising and publicity purposes.*

5.4. Freshers Representative

- 5.4.1. *Responsible for boosting engagement with the society among first year students.*
- 5.4.2. *Represents the views of first year students on committee, should speak to other first years to gather their feedback.*

6. Online Code of Conduct

- 6.1. *Only the Publicity and Speakers Secretary and the President should have access to the Society's Facebook, Instagram and Twitter accounts.*
- 6.2. *The Publicity and Speakers Secretary should use their discretion and only publicise content advertising the society/our events or celebrating our achievements.*
- 6.3. *More contentious political statements should be discussed as a committee before being shared.*
- 6.4. *Our Instagram and Twitter accounts will not be used for sending any person or organisation direct messages.*
- 6.5. *If a person or organisation contacts us via these platforms and we need to respond, this will be facilitated by the President, by email.*

7. Finance

- 7.1. The group's finances shall be administered by The Guild, on behalf of the group's members. Such funds will be held in trust by The Guild on behalf of the group and shall not be used for purposes other than the group's aims and objective.
- 7.2. All funds shall be used as to benefit the largest number of members possible at all times.
- 7.3. Where the group is dormant, The Guild will hold funds in trust until a time when the group becomes active again or is disaffiliated from the Students' Guild.
- 7.4. The group shall follow all Guild financial guidelines, and shall ensure that all monies are handled through the respective Guild accounts.
- 7.5. The committee can endeavour to secure external sponsorship for the group. Any sponsorship agreement must be approved by the Activities team prior to the signing of an agreement or money being received.
- 7.6. Any equipment or other items purchased by the group using group funds shall remain property of The Guild.

8. Safety

- 8.1. The group will follow all guidelines and policies laid down by the Activities Team and The Guild.
- 8.2. The committee must complete their due diligence by risk-assessing all events and activities organised by them in line with Guild procedures.
- 8.3. All events undertaken by the group must be submitted to and approved by the Activities Team within the stated deadlines.

9. Elections

- 9.1. All the Executive Committee shall be elected. Voting shall be by single transferable vote and secret ballot, using the online election system provided by the Guild.
- 9.2. All full members of the society may stand for election in both executive and non-executive committee (sub-committee) positions.
- 9.3. Associate members may not stand or vote for executive committee positions.
- 9.4. No committee members will serve for longer than one year without re-election.
- 9.5. Members should be given at least two weeks' notice of any election.
- 9.6. The group may hold by-elections at any point during the year if a position becomes vacant. The by-election may either be held at an Extraordinary General Meeting or online via The Guild website.
- 9.7. By-elections shall follow the same regulations as regular elections.

10. Meetings

10.1. Committee Meetings

10.1.1. Committees shall hold regular minuted meetings.

10.1.2. Quoracy of Committee meetings shall be 50% of the executive committee plus one.

10.1.3. Any member of the group is entitled to attend any committee meeting, unless it is a closed meeting

10.2. Annual General Meeting

10.2.1. The group will hold an AGM before the end of Term 3, during which the following will take place:

10.2.1.1. each committee member will deliver an outgoing report of the year.

10.2.1.2. the treasurer will present a report of the financial accounts

10.2.1.3. any constitutional amendments will be voted on

10.2.2. All members must be given at least two weeks' notice of this meeting.

10.3. Extraordinary General Meetings

10.3.1. An Extraordinary General Meeting (EGM) for a group may be requested by the committee or at least 10% of the group's membership.

10.3.2. There must be a notice period of at least 24 hours before the EGM and all members of the group must be informed.

10.4. Quoracy of an AGM or an EGM will be 20% of the group's membership.
